WHEN IS IT?


Summer of IP will take place throughout the summer of 2023. We'll be launching officially on Monday 3 July 2023 - but opportunities and event sign-ups will start to

What is Intellectual Property? A recap...


- "Creations of the mind"
- Intellectual property rights (IPRs) protect these creations of the mind
- Copyright protects works such as literary or musical works and computer programs ©





What is Intellectual Property? A recap...

- Patents protect inventions, such as new products and processes
- Trade marks protect brands ®
- Designs protect the shape and configuration of products


- These roles require a whole range of skills, knowledge and interests








Skills to pay the bills


 Careers in patents normally require a STEM (Science, Technology, Engineering and Mathematics) degree





Skills to pay the bills

- To be a good patent attorney, analyst or examiner, you will need:
 - a good analytical mind
 - be good at solving puzzles
 - be good at communicating ideas





Follow up Inventions and Innovations

- There may be further improvements to the technology
- The patent attorney will be kept in touch in case of new inventions

Branding

- It is possible to protect a brand name with a registered trade mark
- Registered trade marks have been examined





Trade mark attorneys


- Trade mark attorneys file trade mark applications
- They providepre-filing advice
- They can also manage the trade mark rights once they are registered





Trade mark attorneys


 To become a trade mark attorney you will need a degree (does not need to be a particular subject)





Trade mark attorneys

- The main skills for being a good trade mark attorney are having an analytical mind and great communication skills
- Trade mark law is very fast moving





Trade mark examiner

- The UK Intellectual Property Office examines trade mark applications
- Trade mark examiners do not require a degree – so may suit people who do not wish to go to University
- Requires a very good analytical mind and good use of language

Designs

- The shape of the sole and the whole trainer itself can be protected with a registered design
- These must be new and have individual character

Designs

- Design registrations are also granted by the UK Intellectual Property Office
- Filed by patent or trade mark attorneys



Enforcement of rights


- Competitors will assess the new sole
- They can copy or design around it
- What roles are there for Intellectual Property professionals from here?





Patent attorneys

- Patent attorneys for the competitors will study any published patent
- Is the patent granted?
- Can the patent/patent application be attacked?



Patent attorneys

- If there is no patent, it will be a lot easier to copy!
- Can the rights be defended?





Intellectual Property (IP) solicitors

- The roles of IP solicitors may overlap with patent and trade mark attorneys
- IP solicitors may have a technical background
- A good business mind





Intellectual Property Barristers

- To court! A competitor has made a shoe with a very similar sole
- Barristers specialise in representing clients in litigious matters





Intellectual Property Barristers

- Barristers will often work alongside solicitors and patent and trade mark attorneys on litigation matters
- Barristers will need similar strong analytical skills as attorneys and solicitors





Finance

- Insurance roles
- Intellectual Property backed lending
- Mergers and acquisitions
- Intellectual Property valuation





Administrative/ Support roles


- Many essential and rewarding support roles do not require a technical background or a degree
- A lot of Intellectual Property work is transactional





Administrative/ Support roles

- Roles and job titles will depend on the firm and the level of responsibility
- High levels of organisational skills and attention to detail
