What is a trade mark?






The Role of a Trade Mark Attorney




Life cycle of a UK trade mark (and what we do at each stage)

How to Become a Trade Mark Attorney



The Pre-Requisites:

- Minimum 2:2 in any subject or appropriate training and/or experience.
- Successful completion of foundation course <u>and</u> advanced course.
- Accumulate 2+ years of supervised training overseen by a Chartered Trade Mark Attorney (this should happen automatically during the course of your training contract).



The Qualifications:

YEAR 1

Bournemouth University – Postgraduate Certificate: Intellectual Property Law & Practice

Starts in January and runs for five months. Delivered over three weekends, supported by online distance learning.

Brunel University London – Postgraduate Certificate: Intellectual Property Certificate

Starts in September and runs for eight months. Delivered Wednesday afternoons.

• Queen Mary University of London – Postgraduate Certificate: Trade Mark Law & Practice

Starts in September and runs as a two-week intensive course, followed by ten two-day sessions between October and April.

YEAR 2

• Nottingham Law School – Professional Certificate: Trade Mark Practice

Starts in October and runs for ten months. The course is built around five intensive study units, usually running from Wednesday to Saturday.
