### **Interaction between Advisory Board and IPIM**

The Advisory Board felt that the interaction worked well around business planning time, when there was a clear sequence of review, input and feedback. They would like more to discuss at other times.

There was a general discussion about the best route(s) for communication between the Advisory Board and IPIM and how the process could be more joined-up. The Board requested a more regular feed, from IPIM, of points for it to advise on, along with a better procedure for communicating and following up on those requests. The alignment of future Advisory Board and IPIM meetings, in an annual cycle agreed well ahead, was seen as a positive move, as was the inclusion of Advisory Board discussion topics as a standing agenda item in IPIM meetings.

Some specific suggestions were made by individual Advisory Board members, for ways in which the Board could support IPIM.

Action: Carol, Sally, Clair and Andrea to liaise over timings of Advisory Board meetings in 2025, to ensure alignment with those already scheduled for IPIM as well as with the business planning cycle, and so as to achieve the requisite two joint meetings next year



### **IP Inclusive 10 years on**

Suggestions for potential priorities as IP Inclusive moves into its next decade:

- A community supporting people from less well-represented socio-economic and/or educational backgrounds
- Widening access to the IP professions, in particular via alternative routes such as apprenticeships
- Improving inclusivity and accessibility in recruitment processes
- Improving inclusivity for support staff
- Keeping an eye on EDI-related developments in the US and their potential impact on public opinion, strategies, policies and resources in the UK
